

# Introduction

### What is a Neighbourhood Plan?

A Neighbourhood Plan is a way for people to get together to influence development in their local area through the next ten to fifteen years. Whilst the principals and guidelines agreed in the Local Plan cannot be changed or disregarded, the Parish can tailor policies can guide housing and employment development, support important local facilities, protect ecologically or historically significant features and influence traffic and transport management.

Each plan is prepared in consultation with local residents and the Parish Council, in accordance with the 2011 Localism Act. Before, during and after it has been prepared local residents, landowners and other interested parties are consulted. The plan will then be examined by a professional inspector and will be subject to a local referendum, before being adopted by Harborough District Council when it will be used to help determine local planning applications.

### Why should I complete this questionnaire?

By completing this questionnaire, you will help us identify issues important to you. All the results will be analysed to ensure the plan reflects the needs and desires of Misterton and Walcote residents. The more responses, the more accurately the plan will mirror local views.
